It is a proposal seeking Environmental clearance for proposed Establishment of Manufacturing industry for Pharmaceutical Steroidal, Active Pharmaceuticals Ingredients at Plot No 67, KIADB Industrial area, Vasanthanarsapura Industrial Area of Tumkuru Taluk, Tumkuru District by M/s. Natural Capsules Limited. This is a project covered under SLNo.5 (f) of the Schedule Under of EIA Notification 2006 and amendments made there on.

3. It is inter-alia, noted that M/s. Natural Capsules Limited have proposed for Establishment of Manufacturing industry for Pharmaceutical Stereof and the Pharmaceuticals Ingredients on a land area of 20,280.00 sqm. The water built up area of is 7,392.00 sqm. The water requirement for the proposed project 2014.5 KL Bodt will be met from KIADB supply/Borewell water. The proposed project Project Physics are manufacturing of 43 products with maximum production capsure of 13070.01 kg/month. The project shall have DG sets of 500 FtVA X.6. and the enclosed Annexure. 4. The project proposal was considered by SEAC during the meeting held on 13th February 2019 and got recommended for issue of ToR. The SEIAA considered the proposal during the meeting held on 2nd March 2019 and decided to issue ToR for conducting EIA study. Accordingly ToR was issued on 27th March 2019 for conducting Environment Impact Assessment (EIA) study in accordance with EIA notification 2006. The project is located within the notified industrial area and hence dors not require public consultation. The EIA has been conducted by Sri S Nanda Kumar S/o Sri. Y Srinivasan , No. 1017, 10th Main. West of Chord Road, 2nd Stage, Mahalakshmipuram, Bangalore-560 086. In respect to whom the notification dated 3.3.2016 of the MOEF&CC stand deferred as per the order of the Hon'ble High court of Karnataka dated 24th March 2017 in W.P.No.12624-12625/2017 has submitted the final EIA report vide letter received on 11th September 2019.

5. Based on the information submitted by you, presentation made by you and your consultant Sri S Nanda Kumar S/o Sri, Y Srinivasan, No. 1017, 10th Main, West of Chord Road, 2nd Stage, Mahalakshmipuram, Bangalore-560 086, the State Level Expert Appraisal Committee (SEAC) examined the proposal in the meeting held on 19th October 2019 and has recommended for issue of Environmental Clearance.

6. The SEIAA Karnataka has considered the project in its meeting held on 22nd November 2019 and after due consideration of the relevant documents submitted by you and additional clarifications furnished in response to its observations and recommendation of the SEAC, decided to accord Environmental Clearance in accordance with the provisions of Environmental Impact Assessment Notification-2006 and its subsequent amendments, subject to strict compliance of the following terms and conditions:

TRANSFER OF ENVIRONMENTAL CLEARANCE

Preamble:

Attention is invited to Authority's letter No. SEIAA 02 IND 2019 dated 13.01.2020 regarding grant of Environmental Clearance for Establishment of Manufacturing industry for Pharmaceutical Steroidal, Active Pharmaceuticals Ingredients at Plot No. 67, KIADB Industrial area, Vasanthanarsapura Industrial Area of Tumkuru Taluk, Tumkuru District to M/s. Natural Capsules Limited and subsequently addendum issued on 04.09.2020.

Natural Biogenex Private Limited vide letter dated 02.03.2023 have requested this Authority for transfer of EC of the above-mentioned Environmental Clearance in favour of Natural Biogenex Private Limited as M/s. Natural Capsules Limited intends transferring its operation/business manufacturing industry to Natural Biogenex Private Limited.

The State Level Environment Impact Assessment Authority, Karnataka considered the request made by Natural Biogenex Private Limited during the meeting held on 18th April 2023 in the light of provision for "Transferability of Environmental Clearance (EC)" under para 11 of the Notification No. S.O. 1533(E) dated 14th September 2006. The Authority after discussion have decided to transfer the Environmental Clearance issued to M/s. Natural Capsules Limited, Trident Towers, Fourth floor, No-23, 100 feet road, Jayanagar II block Bengaluru- 560011 vide letter No. SEIAA 02 IND 2019 dated 13.01.2020 in favour of M/s Natural Biogenex Private Limited, Plot No.67, Phase 2, Vasant Narasipura Industrial Estate, Tumkur District – 572 138 on the same terms and conditions under which the prior Environmental Clearance has been granted and for same validity period.

ORDER

Pursuant to the facts and circumstances in the preamble, the Environmental Clearance granted by our order No. SEIAA 02 IND 2019 dated 13.01.2020 and EC addendum dated 04.09.2020 the name of the proponent may be substituted by M/s Natural Biogenex Private Limited
